## ACCEPTABLE FORMS OF IDENTIFICATION

When applying for a Vital Record, ALL identification must be current and valid

### WHEN APPLYING FOR A VITAL RECORD, YOU MAY USE ONE (1) OF THE FOLLOWING CURRENT AND VALID FORMS OF IDENTIFICATION

1. State Issued Driver's License or State ID (*U.S.-Issued*)
2. U.S. Passport / U.S. Passport Card
3. U.S. Naturalization Certificate
4. U.S. Military Identification Card
5. U.S. Selective Service Card
6. U.S. Immigration Card (*Resident Alien*)
7. Foreign Passport (*with current U.S.-Issued Visa*)
8. Consulate Identification Card (*Matricula/Tarjeta Consular*)
9. Firearm Owners Identification (FOID) Card
10. Global Entry Card

### IF NONE OF THE ABOVE FORMS OF IDENTIFICATION ARE AVAILABLE, YOU MAY USE TWO (2) OF THE FOLLOWING CURRENT AND VALID FORMS OF IDENTIFICATION

11. Social Security Card (*or printout*)
12. Voter's Registration Card (*within 90 days*)
13. W-2 Form (*current year*)
14. Bank Statement (*within 90 days*)
15. Utility Bill (*within 60 days*)
16. Vehicle Registration Card
17. Active Life Insurance Policy (*dated no older than 1-year*)
18. Checkbook or Savings Book (*with name and address*)
19. Work Photo Identification Card
20. Traffic Ticket (*prior to listed court hearing date*)
21. School Photo Identification Card
22. V.A. Medical Card
23. Public Aid Medical Card (*for current year*)
24. Native American Tribal Document
25. Temporary Visitor Driver's License (TVDL)

### PLEASE NOTE SPECIAL REQUIREMENTS APPLY FOR MARRIAGE & CIVIL UNION LICENSES

When applying for a Marriage or Civil Union License, you need ONE (1) of the following forms of identification:

26. State Issued Driver's License or State ID (*U.S.-Issued*)
27. U.S. Passport / U.S. Passport Card
28. U.S. Military Identification Card
29. Foreign Passport
30. Driver's License issued by a U.S. Territory
31. Non-Driver Identification Card issued by a U.S. Territory
32. Firearm Owners Identification (FOID) Card
33. Global Entry Card

If none of the above forms of identification are available, you may use TWO (2) of the following forms of identification:

34. Certified Copy of Birth Certificate (*notarized Eng. translations required*)
35. U.S. Naturalization Certificate
36. U.S. Resident Alien Card
37. Baptismal Record (*date of birth must appear*)
38. Consulate Identification Card (*Matricula/Tarjeta Consular*)
39. U.S. Employment Authorization Card
40. Native American Tribal Document
41. Temporary Visitor Driver's License

### THE FOLLOWING ARE REQUIRED FOR MARRIAGE LICENSE APPLICANTS AGE 16 OR 17

42. Written Parental Consent by all parents listed on EACH Minor's Certified Birth Certificate (*which must be present with a Valid ID*)
43. Second Form of Identification that lists applicant's date of birth **Marriage or Civil Union License Application Fee: \$60.00**
